

CHRONICA TERMS OF USE This is the full agreement ("Agreement") between Chronica Ventures, LLC ("Provider") and users of Provider's Product ("You"). (1) A written notification must be made. This can be done either by fax or written letter (regular mail or courier). E-mails will not be accepted unless a prior arrangement has been made. The notification must: (2) Identify in sufficient detail the copyrighted work that the owner believes has been infringed upon (i.e., describe the work that is being infringed); (3) Identify the item that the owner claims is infringing on their copyright, and provide information reasonably sufficient to locate the item within the Product. For example, "The allegedly infringing work I am referring to is located on the page: [insert Web address]."; (4) Provide a reasonably sufficient method of contacting the owner; phone number and e-mail address would be preferred; (5) (Optional) Provide information, if possible, sufficient to permit Provider to notify the user(s) who posted the content that allegedly contains infringing material. The owner may also provide screenshots or other materials that are helpful to identify the works in question.
